Night Care Assistant

## JOB PURPOSE

The post of Night Care Assistant plays a vital role in the home, and is directly responsible for providing high quality care to the residents according to their individual needs and in line with their agreed Care Plan.

## KEY RESPONSIBILITIES

- 1. Deliver high quality personal care to our residents, (including washing, dressing, toileting and bathing) and carrying out personal appearance tasks (attention to nails, hair, clothes, teeth, hearing aids and spectacles) in a private and dignified manner.
- 2. Meet the emotional needs of our residents by listening to and conversing with them whilst carrying out practical tasks.
- 3. Awareness of each individual resident's social history and utilising this knowledge whilst caring for them.
- 4. Maintain awareness of our resident's changing needs, referring to the individual care plan and inform the Care Team Leader/Night Shift Leader immediately of any changes observed.
- 5. Accurately record all relevant information regarding residents during the night in the home's various recording areas.
- 6. Provide encouragement and support to enable our residents to remain as independent as possible.
- 7. Safely use a variety of moving and handling aids to meet residents' individual needs.
- 8. Assist with snacks and drinks throughout the night in accordance with residents' individual needs.
- 9. Carry out any necessary cleaning duties using relevant cleaning equipment.
- 10. Be vigilant of Health and Safety issues and security of the building and grounds at night and report key concerns to senior staff.
- 11. Work as a team player to create and maintain a co-operative friendly and welcoming atmosphere within the home.
- 12. Attend induction, appraisals and Heart to Hearts, staff meetings and staff training as required and have a willingness to learn.
- 13. Be familiar and comply with all of Care South's policies, procedures, practices and standards.



14. To undertake any other comparable duties as may be required by the management of the home.
